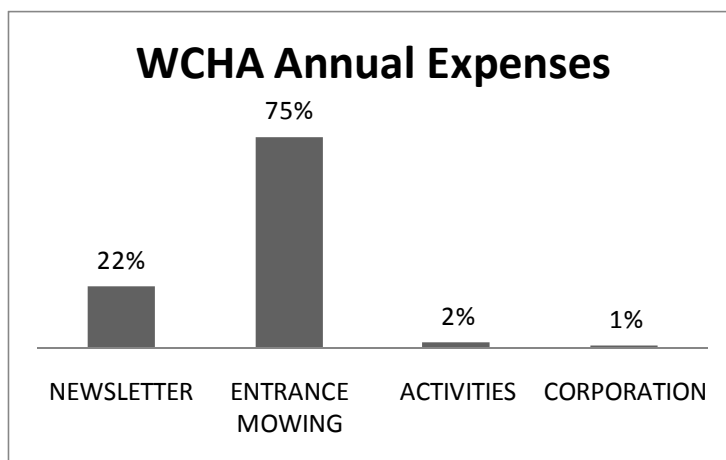
Homeowners Association Dues are Due Again!
